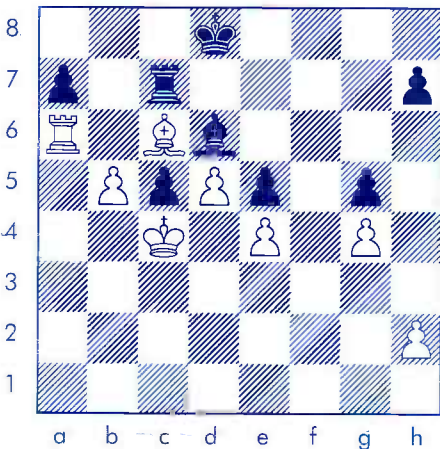

# Patzer Corner

## Amazing Statistics

It has often been said that there are lies, damned lies and statistics, but I wonder if any club player can beat this. In January 1999 when 11-year-old Jessie Gilbert picked up the Women's World Amateur title at Hastings this took my slowplay score against past and present world champions to 3½/4, a staggering 87.5 per cent. My blitz score is 3/3, i.e. 100 per cent, and my overall score is 93.75 per cent. Sounds impressive, doesn't it? How come? Well, here is the breakdown:

Jessie Gilbert - 2/2 slowplay

Rosalind Kieran - 2/2 blitz

Emine Yanik - ½/1 slowplay

Gary Lee - 2/2 slowplay and blitz

The first three are all past and present Women's World Amateur champions; Emine Yanik was the first holder of that title and I held her to a draw - or rather, she held me to a draw! - at the Challengers' last year. That same year, Rosalind Kieran picked up the title; I had previously beaten her twice in a blitz at the first Mindsports. And I had played and beaten Jessie Gilbert twice in a slowplay before she pulled off her coup at Hastings this year. Gary Lee is a member of my club, a moderate but rapidly improving club player. I've beaten him in a club tournament and also in a blitz at the Mindsports. He won the World Amateur Poker Championship at the Mindsports last year. Well, I did say there were lies, damned lies and statistics!

*"Come to think of it, I may well have beaten Lee in another blitz tournament, at my club, but for modesty's sake I won't include that here."*

After submitting this article, Alexander beat Jessie Gilbert again at the Kensington Rapidplay, but it was far too difficult to calculate the necessary adjustment to his statistics, so you'll have to do that yourselves. Any world champions out there who are

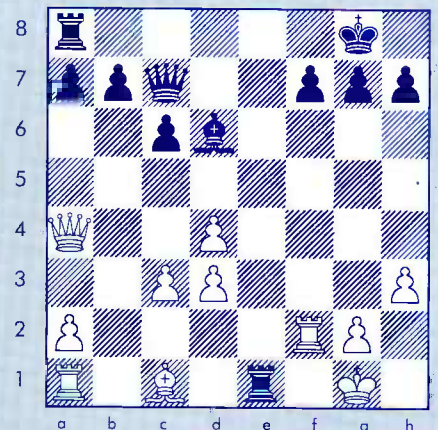
worried about an imminent game against Alexander can use the following brilliancy in their preparation:
