

## Holocaust Affirmers: Bibliography

Like the index, this bibliography was compiled by the author and therefore reflects his inadequacies alone. Many books have subtitles; a quirk of mine is to use a colon between a title and subtitle, but not all authors or book jacket designers do this. Many books are published simultaneously in two or more countries (for example, Chalk & Jonassohn's study *The History And Sociology Of Genocide*, was published at New Haven as well as London); it is my usual "house style" to credit only one place of publication.
