Dear Mr Tyndall,

This letter is written in the strictest confidence. I have no wish to muddy the waters of what is going on inside the BNP, indeed I have no political interest, but I am saddened at the behaviour of both Nick Griffin and Tony Lecomber.

Re the enclosed leaflet, you will doubtless have seen a copy of this already. I gather it was distributed at a Northern meeting recently. How it came into my possession is not important, but you will notice too the quote attributed to you. Some time ago I received an E-mail from Nick Griffin who asked me to check if this quote were genuine. He found it on the Internet, on some left wing site. I assumed he was going to publish a rebuttal. The citation he gave me was Spearhead, 1965, and the quote was given verbatim as follows:

"With the number of murderous asocials and perverts on the increase, as the result of our sick democratic society, there will be the unanswerable case when the day for the great clean-up comes, to implement the final solution against these sub-human elements by means of the gas chamber system."

This is slightly different from the leaflet.

I told Griffin that my first inclination was that it was not genuine, primarily because of the vagueness of the date, but when I checked back issues of Spearhead in a London archive I found that save for the poor citation it was accurate. The full citation, as you of course know, is as follows:

The Case for Gas Chambers, published in Spearhead, February 1965, page 3:

"With the numbers of these murdering asocials and perverts on the increase, as a direct result of our sick democratic society, there will be an unanswerable case, when the day for the great clean-up comes, to implement the final solution against these sub-human elements by means of the gas chamber system."

On the face of it this quote is utterly damning, even though it was written over thirty-five years ago - Tyndall, raving Nazi nutter, etc. Of course, when placed in its proper context it is anything but. Although I am myself opposed to capital punishment, even for child murderers, I am just about old enough to remember the outrage caused by Brady and Hindley, and the fact that they missed hanging by only a few months. We have seen similar public sentiments and revulsion in the wake of the Sarah Payne case. And □

for the record most Moslems, and the vast majority of blacks, are also in favour of capital punishment, certainly for such heinous crimes.

A leaflet like this could have been produced by the SWP, and I am astounded that Tony Lecomber (obviously) was responsible for it; I sent Griffin a copy of the relevant page of the 1965 Spearhead and also spoke to him about it so there is no question that this is a wilful distortion. I cannot imagine why Lecomber hates you so much, and he does hate you; one would have expected some sort of loyalty or even plain common decency to override the public expression of such sentiments.

I met Lecomber on August 13, 1998 to give him some advice about a legal matter; I can't remember the details and they are not important, but he told me then that he was looking forward to the day "My mate Nick" takes over the BNP. I had heard a lot of talk about this at the time but put it down to Searchlight and the usual lies and mischief making, but he assured me that it was neither. I told him I didn't want to know, and heard no more of it until Griffin made his challenge.

I have had no contact myself with either Griffin or Lecomber since last November, and the reason for this was what I consider to be a similar betrayal. In June last year my good friend Morris Riley - who sued and beat Gable - died suddenly from a heart attack. I asked Griffin if he would publish an obituary for him and he asked me to write a 250 word piece, which I did. It wasn't published. Later in the year I asked Griffin what had happened to it; he promised to publish it in Identity, which he did, and when I read the obituary that I had written I was horrified at the way it had been edited.

The editor, presumably Tony Lecomber, had added the claim that Morris had joined the BNP and that he had started a one-man leafletting drive in his home town shortly before his death. I asked for this to be corrected but Lecomber claimed it was true and Griffin backed him up. I pointed out to Griffin that although Morris had no antipathy to the BNP he would not have joined it and did not, and told him that he should either produce documentary evidence to that effect or publish a retraction. Failing that he was not to contact me again. Griffin sent me a long pleading E-mail but refused to back down. This is in stark contrast to our correspondence regarding Eustace Mullins.

Leaving all this aside Griffin's behaviour after September 11 leaves much to be desired; he is stereotyping Moslems and Islam the way the media, Organised Jewry ad nauseum have stereotyped nationalists for decades. A lot of people put this down to pragmatism but I think it is genuine. I tried to explain to him that the vast majority of Moslems are opposed to Zionism, usury and homosexuality, and that most of them are none too keen on miscegenation neither, but he will have none of it.

I am saddened at all of the above because Griffin has been my staunchest supporter. He gave my exposé, of Ray Hill a great deal of publicity, and even promoted my exposé, of David Irving in spite of its controversial nature. Tony Lecomber has invited me to speak at two BNP meetings, and when I turned up early for the last one he took me back to his house and introduced me to his family, so I take no pleasure at severing connections with either of them, but although they have done much to modernise your party, in particular by bringing it into cyber-space, this total lack of integrity in their personal dealings with their friends, even their former friends, has gone too far. When I first contacted Griffin in 1993 he told me that he had no interest in joining the BNP much less leading it. Later he

told me that you had designated him your heir apparent. I don't know how true that is but I do remember the way you too supported me when Gable's ugly friends tried to destroy me in 1996/7, and I think in view of the way you treated both Griffin and especially Lecomber that you deserve better than this.

Further to our previous correspondence, it appears that the offending leaflet was - and probably still is - being distributed by post, albeit on a small scale. I have no details of the meeting where it was distributed except that it was somewhere in the North of England and no more than two weeks before I wrote to you, ie around February 20. From the little feedback I have had no one is paying too much attention to it, even though it obviously reflects very badly on the author. I have no doubt that the Gable gang are laughing up their sleeves.

Recent press reports have reminded me of why I met Tony Lecomber in August 1998. There was talk then of Matthew Collins producing a book about his supposed exploits in the far right. Lecomber and Griffin wanted to nip it in the bud.

A letter - which doubtless you have seen and probably approved - was subsequently mailed to booksellers and distributors dated 10/11/98 and signed Phil Edwards, Press Officer. On November 17, Lecomber phoned me and told me that a second version - with my suggested amendments - had been done and had been/was in the process of being mailed out. He also said he'd had a couple of rude phone calls from recipients. The letter appears to have had the desired effect; I doubt very much this new one will.
