

## ***Alexander Baron - CV***

**Date of birth: August 2, 1956**

**Place of birth: Dulwich Hospital, South East London**

**Education: I attended several primary and secondary schools leaving with 5 CSE Grade 1's; I did one year of further education before dropping out.**

**Around the beginning of 1980 I began reading Revisionist and related literature.**

**From 1988 I began researching the Holocaust and related matters, first in the British Library, then soon at the Newspaper Library, the Wiener Library (briefly), the Public Record Office and the Imperial War Museum.**

**In 1990-91 I worked on a short lived and ill-fated legal campaign.**

**On April 13, 1992 I was admitted to the National Union of Journalists.**

**Over the course of many years I have contributed to numerous journals and websites on various matters, including some relating to the Holocaust.**

**In August 1996 I was arrested after mailing out copies of *Why Britain's Police Aren't Worth A Jewish Fingernail* to police stations; this pamphlet exposes a number of Jewish/Zionist lies about the Holocaust. The Board of Deputies of British Jews complained to the authorities; there was talk of charging me with incitement to racial hatred, although at the end of the day no charges were brought against me in this connection. Instead a corrupt police officer concocted other charges against me and I spent six months on remand in prison before being cleared of all charges by a jury, must to the disgust of the biased and bigoted trial judge.**

**Over the next few years the police made my life a misery, concocting spurious charges against me in crass revenge.**

**Over the past few years I have been dogged by ill-health, in particular by near constant pain due to severe musculo-skeletal disorders.**

**After September 11, I began to lose interest in the Holocaust and related matters because it became apparent to me that there are far more important matters in the world than how the Germans treated the Jews during the Second World War. It has become clear that over the past few years the US Administration has become intent on restructuring the world and in particular the Middle East, regardless of the consequences for World Peace.**

**I would be honoured to attend and to address such a conference; I am particularly impressed by your President, a plain speaking courageous man whose candour is in stark contrast to those of the overwhelming majority of politicians and statesmen anytime Zionism raises its ugly head.**
