The Mildmay Tavern has kindly offered us their venue, so how about a "General Erection" night on May 2nd 97?

CONSULTATION with COPS & CUSTOMS etc.

Tim reported our correspondence and various replies, declining to meet us. Discussion focused upon the lesbian and gay dialogue achieved with the Police Gay & Lesbian Liaison Officer, etc. Some thought our letter-head statement of aims too aggressive to be useful in such efforts and Ivor agreed to redraft them for our next meeting.

NEWSPAPER "CONSENTING

Tuppy proposed that with enough finance raised by Stallion's Night and sponsorship through advertising, we should independently self-publish Issue No 2 @ 10,000 copies of 24 pages to include the National Petition, soon. The meeting endorsed the proposal with enthusiasm, and ideas & volunteers were welcomed.

PROSTITUTION & THE LAW

The second meeting took place in Conway Hall on Sunday 19th March, one hour prior to the public meeting. Discussions revolved around the Prostitution Pride march to the Home Office and it was agreed that the event should be educational. The title was questioned and "Sex Pride" was proposed. Since then, the title "Prostitution Pride on the Sexual Freedom March" is being discussed.

AIMS:

MINUTES of the 7th Plenary meeting of the SFC of 22-1-97, 8.00pm above the Hope pub

Tuppy announced that an ex-prostitute has offered her large house for a party after the March, and everyone will be invited

It was agreed that the laws on soliciting should be abolished but kerb crawling and the nuisance factor were to be matters for further discussion before the Sexual Freedom Bill can be finalised.

The Small Hall had been decorated with purple balloons, banners and posters promoting prostitution rights and soon filled up with people, with Channel 4. Rex Features, Ritual / Hot Stuff and our rown cameramen taking stills and video recordings. Some sex workers arrived of both genders, and representatives from the Network of Sex Workers and Anti. Slavery International.

Jeff spoke of the need for the SFC and Sexual Freedom Bill, John Blandford, the lawyer, spoke of the difficulties involved in law reform. Helen spoke on the ways all the laws make a nonsense of trying to earn a decent living, and Tuppy spoke on the wide ranging topics being covered at the forthcoming conference on prostitution in Los Angeles, and outlined her paper "Disabled People Make the Best Clients" which she will deliver there. She ended by saying laws that restrict access to sex workers to disabled people are inhumane.

Questions came from the floor at a steady pace. Topics discussed were the Spanner case and the legal position on domination, tenancy agreement wording, the reluctance of prostitutes, especially rent boys to "go public" and campaign, the advantages of paying tax, the need for clarity in the law and the importance of teaching people that sexual pleasure is the most important thing in their lives.

The Revd Chad Varah, founder of the Samaritans spoke on several occasions in favour of abolishing the laws surrounding prostitution. When one discussion concluded that gutter press exposés are usually responsible for prostitutes getting busted and for the hypocritical laws not getting struck off the statute books, he stood up and told us that he could never understand why people would want to read the drivel in those papers, and if they could look at hard core porn, they wouldn't bother.

The speakers summed up and Tim Summers concluded with a fab "Goodbye Mary Whitehouse" speech promising to keep everyone informed of progress with regard to our march to the Home Office.

The event was covered in the South London Press but nowhere else, even though all the national TV and newspapers had been faxed a total of 5 A4 pages of advance publicity. Discussion focused on our need to improve our media coverage. Volunteers, Jeff, Ishmael, Iain, Tuppy, Karen, Miki, Robert, Maurice, Dik, Antony & Tim will meet to propose improvements to our act.

Volunteers to speak to the media were Jeff Peacock, Ishmael, Iain, Jeff, Tuppy, Karen, Miki, Robert, Maurice, Dik and Antony. Tuppy invited all these people to let her know in writing exactly WHAT areas they are prepared to speak on, on TV/Radio/with other press.

Confidentiality was sought and assured

NATIONAL PETITION "SEX PLEASE WE'RE BRITISH!"

Robert reported that a first draft of all sex laws in need of change or abolition will be circulated to legal and campaigning experts for advice, hoping to have 10,000 copies of the double-sided A4 petition sheets ready to follow the General Erection, sorry Election, for presentation at the end of our march. Tim drew attention to the massive work ahead for us to achieve a credible amount of signatures in such short time. Tuppy said the Petition covered all major sex laws, but not peripheral laws such as "transsexuals" right to marry".

OTHER REPORTS, IDEAS, INSPIRATIONS

Michael spoke of the work of the c40 people under the aegis of Liberty to moderate rather than oppose the Sexual Offenders Bill currently in the Parliamentary pipeline. A working group to make proposals to the next Plenary attracted the following volunteers: Antony, Michael, Iain, Dik, Peter and subsequently Alastair.

(Liberty's resolution on the Sexual Offenders Bill had been circulated to all supporters, but expired its deadline before the SFC could endorse it.)

Tuppy reported that the British Entertainments and Discoteque Assoc (BEDA) is actively campaigning against the proposed laws on drugs in clubs. It was unanimously agreed that the SFC should seek the support from this group, although we agreed that SFC does not advocate the taking of drugs.

A draft letter proposing legal prostitution and opposing **Streatham's residents-only traffic bollards** (designed to eliminate kerb-crawling) was agreed for immediate dispatch.

Jeff kindly offered us office space at the ground floor rear of his shop, and volunteers to set this up were Karen, Ivor, Dik, Richard, Caroline & Tim. Although several people confirmed that groups can be run by a rota of individual volunteers from a small office, Maurice warned that having an office doesn't always bring progress, and can bring collapse to organisations.
