

AGENDA FOR GENERAL MEETING OF NCROPA TO BE HELD ON  
WEDNESDAY 2nd MARCH 1983 AT CONWAY HALL RED LION  
SQUARE HOLBORN LONDON WC1 at 7.30 pm (nearest Underground  
Holborn)

Committee Members are asked to arrive at 7.00 pm so that the Committee can have a brief discussion before the meeting is formally opened at 7.30 pm. The meeting must end by 10.00 pm when the Hall will be closed.

Entry to the meeting will be by invitation letter to members only. Copies of the balance sheet regarding NCROPA accounts will be on each chair for members to read in the Hall. *Guests of members who arrive will only be allowed in if they first become members at the door.*

The meeting will be opened by Edward A C Goodman, in his capacity as Legal Advisor to NCROPA, who will welcome the members and outline the agenda to them.

- (1) The General Meeting will be asked to approve the abolition of the post of Organiser and its replacement by the more formal post of Director. The meeting will be asked to approve the appointment of David Webb to that post.
- (2) The General Meeting will be asked to approve the NCROPA Committee. The General Meeting will also be asked to give the Director power to co-opt new committee members in consultation with the Committee. Members who are not on the Committee but are prepared to help with its work, especially females, will be asked to write their names down in a booklet which will be passed round.
- (3) Edward A C Goodman will explain to the members that while suggestions for future activities will be welcomed, they must remember that NCROPA has no funds and therefore cannot undertake activities which cost money. He will then explain that it is proposed to increase the subscription from £2 to £5 plus any extra which any member can generously give. The subscription will be halved for students, senior citizens and the un-waged. It will be explained that no member of the Committee is paid for his or her work and that NCROPA funds are solely used to pay expenses incurred by the organisation.
- (4) Edward A C Goodman will then explain to the meeting that the rest of the evening will be taken up by a report from the Director dealing with the activities of NCROPA since it was founded seven years ago, other than those detailed in the booklet "NCROPA IN ACTION" which all members have been sent. Director will then answer questions by members, <sup>and</sup> there will be a general discussion. Edward Goodman will explain that the meeting must end by 10.00 pm and therefore questions and/or contributions by members must be brief so as to give every member who wishes to speak a chance to do so.

It will also be explained that the Director will refer specialist questions to that member of the Committee who deals with that topic eg legal questions will be referred to Mr Goodman and questions about the situation in the West End will be referred to Mr Miller. Mr Goodman will then hand over the chair to the Director.

- (5) The Director before *delivering* his report will point out to the members that a large quantity of badges are on sale in the hall and that members are encouraged to buy and wear them so as to publicising the cause.
