Ben Whitaker, the Chairman of the Defence of Literature & the Arts Society, has promised to put my proposals to his executive committee meeting on Wednesday evening and Mrs. Enid Wistrich, the Greater London Councillor, who is also an that committee, has invited me to attend. I have decided to do so but have pointed out that I cannot accept any dilution of the proposals I have expressed because it really

is high time that the "anti-censorship, anti Obscene Publications Acts lobby" mustered its forces and its many protagonists stood up, tearlessly and umashamedly, to be counted. Dr. Richards agrees most strongly with these sentiments and I think and hope that you do likewise.

Suggestions for possible committee members are being slowly but surely put forward by various parties and I'm doing my best to follow up every seemingly worthwhile suggestion but this does, of course, take time.

I know that you are waiting to hear from me when we're ready for "the off" but I thought I should bring you a little more up to date with what's been esappening.

Meantime all good wishes and I hope to be in touch again very soon.
