CLEAR-SIGHTED CHAIRMAN!

n the day (2nd January 1991) the Broadcasting Standards Council became operational, Lord Rees-Mogg, its Chairman, launched an attack on what he called "children of the sixties" who make programmes in which they impose their permissive values on viewers. He told the Daily Mail in a special interview, that he intended to reverse the trend and put the viewer in charge of what was shown. He said, "The people now making programmes were students in the 1960s when there was a revolutionary change in social conscience and a great breaking-down of taboos. That affects what we see on our screens.

"We are going through a period in which people taking the decisions in television are the children of the 1960s, people who were students at the end of the 1960s, people under 45. The power lies with the producer age group. But the parents of young children are normally in their twenties or thirties."

The broadcasters' argument that you could always switch off the set was arrogant, said Lord Rees-Mogg. "What they are saying is if you don't like it, you can lump it. Broadcasters should not take their decision in a social vacuum."

In ordinary family life the balance was imposed by what the mother would allow in the home. "People feel that television is imposing lower standards than they themselves want. They want TV to be careful when children are watching. Adult films at 11pm are not such a problem."

He intends that the BSC which began its monitoring work yesterday (1st January 1991), should end the 'producer monopoly' of television. The programme-makers, for the first time, will have to bow to the public's views.

"The consumer ought to be sovereign in television as in everything else. That is what democracy is all about."

Lord Rees-Mogg revealed that two panels of around 770 members of the public — men and women, dustmen and barristers, young and old, the well-heeled and the unemployed — will watch the output of all TV stations, both terrestrial and satellite. They will pass their views to the new council, which will meet to hear complaints about TV and radio from January onwards.

For highly controversial programmes, a 750-strong panel chosen at random by a leading market research firm from telephone directories will be on stand-by.

If a complaint is upheld by the council, it will publish a judgement or publicise it in the press. In very serious cases a statement will be read out on television.

With such headlines as these the Cumberbatch report on whether there was a link

between pornography and violent crime was almost universally dismissed.

This research was set up by the Government under the leadership of Dr. Guy Cumberbatch of Aston University and Dr. Dennis Howitt of the University of Loughborough at a cost of £650,000.

National VALA was not the least surprised by the unsatisfactory results of this research and was much encouraged by the stand taken against it, not least by Detective Superintendent Michael Hames, head of Scotland Yard's obscene publications squad: "The report says you can't prove a link between pornography and crime — we know that. I cannot prove a link either, but I can tell you from bitter experience that the sick deluge of pornography is on the increase and so is violent sexual crime."

Mrs. Mary Whitehouse, president of the National Viewers & Listeners' Association, said the report was a waste of public money. "This is just another of the highly controversial reports that get us nowhere. It's high time the Government had the courage to say simply and categorically that pornography is an increasingly evil blight on our society, and take steps to deal with it."

"WE ARE NOT EXAGGERATING"

The following is an extract from what was said during *Public Eye* BBC2 TV 19th October 1990.

66 here are no national statistics on child abuse network crime, but police are becoming increasingly aware of network rings from videos and contact magazines seized from those involved in them. They believe that what they uncover is only a small proportion of the actual networks that operate all over the country. What the Authorities fear is that those caught up in these paedophile rings will become abusers themselves once they reach adolesence." Supt Michael Hames said "Breaking into a network of child abusers is like no other area of police activity in the sense that by comparison burglars and robbers

"I think we've come to accept that there is child abuse within the family and, certainly all over the country, child protection teams have been set up to deal with the abuse, but following on from that we've now begun to discover that there is a tremendous amount of abuse from outside the family. I can tell you that we are not exaggerating when we talk about the extent of network child abuse, because every week we are receiving more and more information about networking.

"Three years ago we started an index of names of people who had been dealt with for sex abuse of children — that was from zero and we are now well above the 3,000 . . . it is rising every day.

"The fact is that children are being abused in all of the towns, cities and villages in the country".

Public Eye said "Six officers at New Scotland Yard now work full time investigating child pornography and paedophiles.

"Dr Nick Wild, Consultant Paediatrician, discovered, over a two year period in Leeds, 31 child sex rings involving 334 children and almost 50 perpetrators. Public Eye carried out a national survey on organised network child sex abuse over three years. They wrote to every police force in the country: three quarters of the 52 forces responded. 18 had no experience of these problems. 186 separate cases were reported involving 1,812 victims — many revealed a large number of linked offenders.

"For example, Northumbria – 61 suspected cases involving 161 children; West Mercia – 12 networks involving 165 children.

"Police say that it is so hard to trace networks . . . these cases are the tip of the iceberg.

"The transition from victim to abuser is common. Child abuse experts say 40% go on to abuse. Dr Gail Ryan, of the University of Colorado, USA, says over half of the boy victims and a fourth of the girl victims are being abused by adolescence".

PETITION TAKES OFF!

or weeks now hundreds of letters have been coming in from people of all walks of life and from all over the country, even from the Hebrides and the Orkneys.

They are from people and from organisations who have seen a letter from Mary Whitehouse in their local newspaper announcing the Campaign to Outlaw Pornography. Many of the writers express their own concerns and why they are backing this Campaign and why they are asking for petition forms.

In her letter, Mrs. Mary Whitehouse CBE spoke of people being deeply shocked and concerned about the appalling reports of child sexual abuse that have come to light in Britain during the past few months and how, in case after case, it had been revealed that pornography had played a key role in the corruption of the minds of those who have often tortured as well as sexually abused the children, leaving them physically and mentally damaged.

One young lady collected a full sheet of 74 names by standing outside Sainsbury's. She has now written to Mr. Sainsbury asking if she can do it inside instead of outside in the cold! Others have got together a team of 20 people to collect signatures in shopping areas using clipboards and a poster. One man in a wheel chair did this in Bournemouth and fell out of the chair and had to go to hospital for stitches in his head. That did not deter him — he was soon back again collecting more signatures!

STAYING IN CONTROL

eorge Russell, as Chairman of the new Independent Television Commission (ITC), launched on 1st January 1991, controls what we will watch on commercial television into the next century. He has championed a system of quality through regulation outlined in the 1990 Broadcasting Act.

His proposals for a "quality threshold", which bidders for ITV franchises would have to pass before the size of their bids was considered, were adopted by the Government. Mr Russell will oversee the largest and most significant contest ever seen for the coveted licences.

Those who fall below the rigorous quality requirements will face a penalty point system, which will lead to fines. Fines for continual misdemeanours will grow in size. "It will get more and more expensive for those disregarding their obligations on quality, to the point where it would be much cheaper for them to invest more money in quality output. But with a certain number of breaches, the franchise will be removed" he says.

HEAR, HEAR!

The National Consumer Council recently published the results of a survey, conducted by MORI, investigating what people think about some of the services they use every day, including television.

The consumers were asked if they were satisfied with the overall service they received, what they felt about price and quality and whether they felt that those providing the service adequately listened to their complaints and suggestions.

Opinions about radio and television programmes contrasted strongly. Only 6% expressed dissatisfaction with the quality of radio compared with over 50% for television. Only one-third were satisfied with the quality of TV programmes, two-thirds with radio.

Among all the key services in the survey, the price of a television licence was felt to be the most unreasonable; 39% said that the cost of a licence was very unreasonable. Consumers obviously felt that they were not getting value for money.

Television companies were not seen as looking after consumers well, although independent companies were slightly better than the BBC. People's leisure activities are an important part of their lives. But in this survey it was found that there is a clear message for television to devote more time and attention to consumer consultation.

Consumers do not feel they are receiving value for money or that they are listened to.
