## Frontierguy03 → Hendrik Vanderstijn - a year ago

According to Statistics Canada, 43% of reported sexual assaults result in charges, and 56% of charges result in convictions. If you do the math, after investigation by law enforcement and adjudication by the courts, only 24% of reported sexual assaults are found to be true. Source: N.B. Non-true and false accusations are two very different things. A false accusation is one that is intentionally and knowingly false, whereas non-true accusations include cases where the accuser was honestly mistaken (for example misremembered details leading to the arrest of the wrong person) or where the proof is simply insufficient to prove either the truthfulness or the falseness of the accusation.
